2022 Long-Term Care Medicaid Coverage Groups 2022 Substantial Gainful Activity (SGA) Limit 2022 Medicare Premiums and Coinsurance Rates

DATE: November 15, 2021

Supplemental Security Income (SSI) Standards

Effective January 1, 2022, the cost-of-living adjustments for the monthly Social Security and Supplemental Security Income (SSI) Federal Benefit Rate (FBR) will increase 5.9 percent. There are no changes in the SSI resource limits.

- 1. The FBR for an individual is \$841 and \$1,261 for a couple.
- 2. The FBR for an individual living in the household of another is \$560.67 and \$840.67 for a couple (LA-B).
- The PNA is \$70.00
- 4. The living allowance for each ineligible child is \$420.33
- 5. The value of the one-third Reduction Factor (VTR) is \$280.33 for an individual and \$420.33 for a couple.
- 6. The presumed maximum value (PMV) of in-kind support and maintenance (ISM) is \$300.33 for an individual and \$440.33 for a couple.

Medicare Premiums and Coinsurance Rates

The Centers for Medicare & Medicaid Services (CMS) updates the premiums, deductibles, and copayments made by Medicare beneficiaries each year. The following amounts are effective January 1, 2022:

Medicare Premiums and Deductibles for 2022

Part A Premium: Up to \$499.00

Part A deductible: \$1556.00 per benefit period Part A skilled NF coinsurance \$194.50for days 21 through 100

Part B standard premium: \$170.10 (or higher depending on income) *

Part B deductible: \$233.00 per year

*Most people who get Social Security benefits will pay less than this amount (\$170.10 on average).
